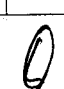
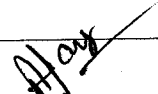

	<b>Physical Properties</b>	Appearance : White or light grey Weight : 500 mg(+/-2.5 mg) per tablet Available Chlorine : 25 to 45 mg
	<b>Chemical Properties</b>	Chemical Name : Calcium Hypochlorite
	<b>Volume of Water to E Treated</b>	One Tablet of 500 mg has to be used for 20 litres (approx) of drinking water.
	<b>Test and Inspection</b>	All product quoted should be supported by a test certificate issued by accredited laboratory indicating confirmation to the required standards.
	<b>Shelf Life</b>	The product should have 3/4 <sup>th</sup> of the shelf life when supplied.

1.	EMD	Pursuant to clause 15 of the Conditions of the tender, EMD deposited by your firm has been converted into performance security. This security will be kept till the Rate Contract Period as security amount for performance of contract.
2.	Performance Security	Apart from above you have to submit Performance Security equivalent to 5% of the value of the supply order within 7 days from the issue of supply order under this Rate Contract in the form given in the tender document clause 31 (This will be applicable for orders to be issued by State Headquarter i.e. Punjab Health Systems Corporation (PHSC)).
3.	Terms of Delivery	<p>Supply orders will be placed by the Direct Demanding Officers (DDOs) nominated by the Managing Director, PHSC. Presently Director (Procurement), PHSC is DDO for operating this Rate Contract.</p> <p>Supply orders will be placed from time to time during the currency of the contract in which the exact quantities required on each occasion together with the date of delivery shall be specified by the Direct Demanding Officers.</p> <p>Supply orders against the contract will be accepted as long as these reach the contractor on or before the last date of the currency of the contract. Supply orders received during the closing days should be complied with in due course, in accordance with the contract, even though in some cases, owing to contract having expired, supplies are to be executed after the expiry of the last date of contract</p>
4.	Delivery Conditions (clause 26 of the tender document)	<p>a) <b>Delivery Period:</b> Delivery must be completed within 30 days from the issue of award.</p> <p>The successful tenderers shall make deliveries against supply orders within 30 days from the actual date of dispatch by e-mail/online application. In case of failure to supply, the DHFW Punjab reserves the right to purchase the stocks from other sources as risk purchase, i.e. purchase from any other firm or firms, in the rate contract or from outside the contract at the discretion of the Direct Demanding Officer concerned at a competitive rate.</p> <p>b) Immediately on receipt of the order, the supplier should confirm the receipt of order and inform the tentative schedule by which the material will be supplied by the supplier. In case the supplier is not in a position to execute the award wholly or partially within the stipulated delivery period, the supplier must inform the PHSC in this regard within 5 days from the date of dispatch of order, so that alternative arrangement for procurement from matched bidder/outside the Rate Contract may be made by the purchaser for meeting emergent requirements at the risk and cost of the supplier. In case no confirmation is received from the supplier regarding execution of order within the stipulated delivery period, it will be presumed that the order will be executed within the delivery period and in case it is not executed within the stipulated delivery period, action will be initiated against the bidder for debarring/risk purchase.</p>
