To implement 'Bio-Medical Waste Management Rules, 2016', in the State of Punjab, the State Advisory committee under the Chairmanship of Principal Secretary, Health and Family Welfare to Govt. of Punjab is constituted and notified. The State and District committees shall work for proper management of bio-medical waste generated in the Government facilities, monitor the compliance of the provisions of the rules for effective implementation and to improve the collection, segregation, processing, treatment and disposal of the bio-medical wastes of the State thereby, reducing the bio-medical waste generation and its impact on the environment.

#### **Terms of Reference:**

1. The District Level Monitoring Committee shall be responsible to monitor the compliance of the provisions of the rules in the Healthcare facilities generating Bio-medical waste.



2. The committee shall also monitor the common bio-medical waste treatment and disposal facilities where the bio-medical waste is treated and disposed of.
3. To ensure maintenance of records related to generation, collection, reception, storage, transportation, treatment and disposal and is in accordance with the rules in each of the facility of the district.
4. The District Level Monitoring Committee shall meet once in six months and submit its report to the State Advisory Committee concerned for taking further necessary action.
