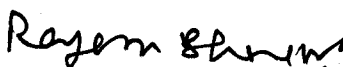
1.	Security Deposit	:	EMD deposited by your company amounting to Rs. 1,00,000/- against the above item has been converted into performance security. 3.	Terms of Delivery	:	Supply orders will be placed by the Direct Demanding Officers (DDOs) nominated by the Managing Director, PHSC. Presently Director (Procurement), PHSC and Joint Director (Procurement) , PHSC are the DDOs for operating this Rate Contract:- Supply orders will be placed from time to time during the currency of the contract in which the exact quantities required on each occasion together with the date of delivery shall be specified by the Direct Demanding Officers. Supply orders against the contract will be accepted as long as these reach the contractor on or before the last date of the currency of the contract. Supply orders received during the closing days should be complied with in due course, in accordance with the contract, even though in some cases, owing to contract having expired, supplies are to be executed after the expiry of the last date of contract
4.	Delivery Period	:	Within 14 days from the issue of Indents/orders by the DDOs. To be read with tender Clause no 26 of General Terms and Conditions for the Rate Contract.
5.	Penalties for late supply	:	Penalty @ 0.25 % per day of the value of the order not supplied within the stipulated delivery period will be levied. For details, please refer to the tender clause no. 27 (a) and 27 (b) of the General Conditions for the Running Rate Contract.
6.	Payment Terms	:	90% payment will be released to the supplier on receipt of the goods at Warehouses and receipt of verified bills, Material Receipt Reports and Test reports in respected of each batch submitted by the supplier. 10% payment will be released to the supplier on acceptance of the material after the test report from empanelled laboratories/Government Laboratory. Please refer to the clause 25 of the General Terms and Conditions for the Rate Contract.

7.	Testing of Drugs	:	<p>a. The principal manufacturer/supplier shall ensure that In-house test report in respect of each batch should accompany supplies made under this Rate Contract and these test reports should be Sent alongwith invoices.</p> <p>b. Regular and random testing of drugs will be under taken from Government / Government approved Laboratories at the time of supply and at any time during the shelf life or whenever any defect is noticed.</p> <p>c. For post delivery testing of the drugs supplied , the supplier shall provide method of analysis of drug formulations of individual active drugs and Fixed Dose Combination as the case may be and sufficient quantity of each API of formulation free of cost for testing of the drugs for which their bids have been accepted.</p> <p>d. The report of the Government / Government approved Laboratory shall be accepted by the firm. In case the same is disputed by the firm giving reason, the report of the Appellate Laboratory only will be accepted as final and the same should be submitted within three months, from the date, the disputed test report is communicated to the firm. For this, the firm should approach the concerned Drug Control Authorities for getting the drugs tested as per procedure from the Appellate Laboratory.</p>
8.	Marking	:	<p>Each packing shall be marked with nomenclature of the drug and shall be labeled in accordance with the requirement of the Drugs and Cosmetics Act, 1940 and in rules made thereunder.</p> <p>The supplied material shall carry printing/markings "Punjab Government Rate Contract supply not for sale"</p>
9.	Packing	:	<p>The packing of the material should be strictly as per packing specified in tender documents clause no 12 and 13 of General Terms and condition for the Rate Contract.</p>
10.	Shelf Life	:	<p>Drug supplied should have minimum 5/6th remaining shelf life at the time of delivery. Please refer to clause 14 of the General Terms and condition for the Rate Contract.</p>
