**Subject: Amendments in the rates of User Charges concerning to Blood Banks.**

This is in partial modification to our earlier letter issued under No. PHSC/Accts./719-972, dated 25.6.2014 vide which revised rates from 1.7.2014 for the various procedures, tests, and other interventions were communicated. It has been decided at the level of the State Government that revision made in the Blood Bank charges are withdrawn from 1.7.2014. Now, the rates for the Blood Banks will be as under;

1	Service charges (including bags/ bottles etc.) for testing blood transfusion. (Patient suffering from thalassemia, obstetrics hemophilia, diagnosed cases of cancers, leukemia, a plastic anemia road side cases of accident and burn cases where the percentage of burns exceeds 37 will be exempted from such charges)	Applicable rates w.e.f. 1.7.14. (Amt. in Rs.)

	c) Govt. Hospital other than the Punjab Govt. Hospitals	1000
