The period of liability after the accident has not been specified	It was decided that in case of accident within the policy period, the liability of the company will be there in case the death or disability occur within 12 months.
It was raised by all the companies that premium in PA policies are paid in advance.	It was clarified that premium of installment which has been linked with the Health Insurance Policy, however, amount of 1st installment will be paid as Rs. 25.00 lacs instead of Rs. 10.00 lacs.
Companies asked for exclusion of refund premium clause.	Not agreed.
Companies asked for approximate date of closer of enrollment.	It was clarified that since, recently, we have made certain modifications in the software, so the period cannot be specified at this stage.
Companies asked for the cost of seat for 104.	It was specified that no extra cost is to be paid by the companies for this.
It was clarified by the companies that any accident, which occur due to influence of alcohol or drug will not be honoured as per IRDA Guidelines.	Agreed.
Companies asked for clarification regarding commencement of the policy.	It was clarified that policy will commence from 1.1.2016 and will be co-terminus with the main Health Insurance Policy i.e. 31.10.2016.
