Quotation Form

For the supply of Knapsack Spray Pump, Stirrup Pump/Foot Spray Pump & Hand Compression Continuos Spray Pump

Terms and Conditions:

- 1. The bidder should have market standing for supply of Quoted items during previous year (2013-14).
- 2. The Technical Specifications of various type of Pumps are attached as **Annexure-I** along with this Quotation form.
- 3. The quotations should be submitted in a **sealed envelop super-scribed as "Quotation for supply of _____ Pump"** and the quotation should be addressed to Director (Proc), PHSC, SAS Nagar, and must be submitted before **9.2.2015 up to 11:30 am** in the box placed in Room No. 17, of PHSC, Mohali. Quotations can also be submitted through post. However in case quotations is sent by post, it must reach the office of Director (Proc), Room No. 17, PHSC, SIHFW complex, Phase-VI, SAS Nagar on or before **9.2.2015 up to 11:30 am**. Quotations received after the date and time specified above will not be entertained.
- 4. Sealed quotations will be opened by a committee of PHSC in the committee room of the PHSC on **9.2.2015 at 12:00 noon** in the presence of the representatives of the bidders who wish to be present during the quotation opening.
- 5. Quoted rates should be valid for 90 days from the date of opening of the quotations.
- 6. The Bidder should quote rates on FOR delivery basis at Storekeeper (FW), Parivar Kalyan Bhawan, Sector 34-A, Chandigarh.
- 7. These terms and conditions should be signed and stamped by the bidder and should be submitted along with the quotation.
- 8. Total Landed price per unit (including all taxes) will be taken into consideration for evaluation of quotation.
- 9. The bidder has to submit the following documents along with the technical bid:
 - a) Requisite EMD in the shape of bank draft of the amount specified in NIT.

- b) Bank Draft of Rs 500/- towards quotation document fees, if downloaded quotation document is used for submission.
- Compliance statement for the item supported by original product c) catalogue/brochure/product literature clearly highlighting the technical specifications asked in the bid.
- d) Details of supplies during the previous year with copies of purchase order and performance certificate issued by the clients.
- e) Latest Sales Tax Clearance Certificate and Copy of latest ITR and copy of PAN.
- f) Notarized Undertaking that the bidder is not blacklisted/debarred by any Govt. undertaking in India
- 10. The quotation must be accompanied by the earnest money deposit as specified in Notice Inviting Quotation. The earnest money should be in the form of Bank Draft in favour of Managing Director, Punjab Health Systems Corporation payable at SAS Nagar or Chandigarh. **Quotations not accompanied by the earnest money will be rejected straightway**.
- 11. The bidder should clearly mention the quoted model of item along with product catalogue and compliance statement.
- 12. Only one model/option should be quoted. Quotation of the bidder quoting more than one model/option of any item shall be rejected straightway.
- 13. The earnest money of the successful bidder for the item for which the concerned bidder is found to be lowest evaluated Substantially Responsive bidder will be retained as Performance Security and will be refunded on successful execution of the order. Earnest money of unsuccessful bidders will be refunded.
- 14. The earnest money and performance security can be forfeited, if the bidder submits any wrong information / statement in his quotation or if the bidder fails to execute the order satisfactorily.
- 15. In case, downloaded quotation document is used for submission, the bidder should attach bank draft of Rs 500/- in favour of "Managing Director, The Punjab Health Systems Corporation" payable at Chandigarh/ Mohali" towards cost of the quotation document. The quotation not accompanied by quotation form fees shall be rejected straightway.
- 16. The equipment will be inspected by the inspection team nominated by the Managing Director, PHSC once the equipment is ready for supply and intimation in this regard is given by the supplier to the PHSC. In case any equipment/item is not found as per the specifications, such equipment/item will be rejected. In such a case, no payment of the rejected supply will be made. The firm shall be directed to replace the rejected lot with the supply of specified quality within prescribed time. In case, the firm is unable to do so, then the department has right to forfeit the entire security deposit.
- 17. The equipments must be supplied within 45 days (Forty Five days) from the issue of Notification of Award. If the successful tenderer fails to execute the supply order within the stipulated period penalty @ 0.50 % per week of the value of the order not supplied will be levied. The maximum penalty for late supply shall not exceed 10% of the total value of the order/orders. The cut of date of delivery period shall be counted from the date of actual dispatch of supply orders to date of receipt of supplies at FOR destination. A successful tenderer can extend the delivery period with the agreement of Managing Director (PHSC), if he is not in a position to execute the order in time and in this situation penalty will be levied as mentioned

above and the concerned bidder may be blacklisted/ debarred for participating in quotations/tenders to be called by the Department of Health and Family Welfare, Punjab (That includes, DHS, DFW, PHSC, NRHM) for a period of 2 years.

- 18. The bidder will have to give demonstration of the quoted equipment at Punjab Health Systems Corporation, Mohali at a seven day notice, if so desired by the committee of purchaser's office before finalizing the bids at the cost and expenses of the bidder. The bidder is requested to keep the quoted equipment ready for demonstration at seven days notice. The quotation of the bidder who fails to give demonstration on notified date, time and place shall be rejected straightway.
- 19. The Model offered should be latest and not re-furbished.
- 20. The quantity stated while calling quotations in schedule enclosed can be overdrawn, underdrawn or even undrawn.
- 21. Quotations received late or by telex/fax will be summarily rejected.
- 22. The equipment/material must be supplied in packing recommended for supply of such equipment/material.
- 23. Payment will be made only after satisfactory receipt of the equipment/material in the store of the office along with inspection note and installation report (in case of equipment) at the concerned consignees.
- 24. The bidder should submit a notarized undertaking certifying that the bidder is not debarred/blacklisted by any State Govt/undertaking/department.
- 25. In case of any dispute, the matter will be referred to the sole Arbitrator for amicable settlement and Principal Secretary Health and Family Welfare; Punjab will be the Sole Arbitrator. **The venue of the arbitration shall be Chandigarh /SAS Nagar, Mohali.** In this clause the expression the Principal Secretary Health and Family Welfare, Punjab. means the Principal Secretary Health and Family Welfare, Punjab for the time being and includes, if there be no Principal Secretary Health and Family Welfare, Punjab the officer who is for the time being the Administrative Secretary, Department of Health & Family Welfare, Punjab whether in addition or otherwise.
- 26. All the disputes relating to this procurement shall be subject to the territorial jurisdiction of Chandigarh Courts.
