## TO CONSIDER AND APPROVE IMPLEMENTATION OF NEW SERVICE REGULATION FOR THE PHSC EMPLOYEES.

## **AGENDA NOTE:**

The Board of Directors in its 7<sup>th</sup> meeting held on 20.3.1998 while considering agenda item No. 7.6, approved following regulations for the contractual employees working in the corporation.

- i) Chapter-I Terms and conditions of appointment.
- ii) Chapter-II Traveling Allowances.
- iii) Chapter-III Types of Leave.
- iv) Chapter-IV Contributory Provident Fund.
- v) Chapter V Medical Regulations.

From time to time, keeping in view the administrative requirements, amendments were made in the above regulations vide agenda item No. 12.9, 21.8, 22.9 and 28.13.

- 2. The State Govt. with the approval of the Cabinet has regularized the services of 377 contracted employees of the PHSC w.e.f. 1.11.2011. The employees working in PHSC are now not on contractual terms and their service conditions and other rules require change/amendment.
- **3.** In order to change/amendment the service regulation of the PHSC, following two options can be exercised.
  - i) We may adopt government rules and regulations amended / to be amended from time to time, which has been specified under "Civil Services Rules" as per following details as the State Govt. through various instructions have specified time to time that the pay and allowances of the employees of the Board and Corporation should not be more than Government employees.
