Subject :- Tender for IEC Publicity Vans: Forfeiture of EMD and debarring from participation in tendering process of the PHSC for a period of five years.

Please refer to the subject cited above.

This office has invited tenders for IEC publicity Vehicles for running 30 days "Sehat Jagrukta Muhim". Your company also participated in the bidding process and emerged as L1 bidder and therefore a Notification of Award was issued to your company vide No. PHSC/Proc/IEC Vans 2016/9308 dated 26.08.2016 for providing 118 IEC publicity Vans for 30 days within 18 days from the issue of Award letter. However your company vide letter no. Tel/PHSC-IEC Vans/001 dated 29.08.2016 expressed inability to accept the above mentioned Notification of Award by citing the following reasons

"The core production team of the company which were recruited for this project was currently located at Africa for the similar publicity campaign Assignment. Unfortunately due to Sickness of Yellow Fever out of three core team from five team members. They are unable to travel back to India to handle the same project"

Consequently a Notice was issued by this office to your company vide reference No. PHSC/Proc/IEC Vans 2016/Notice-1 dated: 29.08.2016 through which your company was informed as under :

That activity of providing IEC publicity vehicle is an important date and time bound activity envisaged by the State Government and expressing of inability by the successful bidder at this stage is not acceptable. Therefore notice is hereby issued to your company to explain your position in person in this office on 30.08.2016 at 1:00 pm in room no 14. The representative of your company deputed for attending the personal hearing must come fully prepared alongwith supportive documents to explain the position of your company. Please note that if you fail to attend the above scheduled personal hearing or fails to explain your position satisfactorily, this office will be constrained to initiate following actions against your company without any additional notice:


- 1. To forfeit the bid security submitted by your company against the above tender.*
- 2. To recover the differential amount of the contract price for providing IEC publicity vans which this office has to actually incur and the contract price finalized with your company as per above cited Notification of Award.*

3. To debar your company from participating in tendering process initiated by this office for a period upto 5 years.
4. To initiate other necessary action against your company as deemed appropriate by the competent authority.

Thereafter your company representative Sh. Sh.Dinesh Singla, Head, Accounts and Finance and Sh.Radhey Shyam, Production Manager appeared before the Committee of this office on 30.08.2016. However, your representatives could not state/explain any convincing reasons for non-acceptance of the Award by your company for providing IEC publicity Vans. Your representatives even did not provide, any documentary evidence in support of the reasons cited by your company for non execution of Award. The committee of this office provided another opportunity to your representatives for reconsidering the decision till 12:00 noon, 31.08.2016. However on 31.08.2016 also, your representatives refused to undertake the work.

You are very well aware that lot of time , effort and expenditure of the State has went into the finalizing of tender for this activity and refusal by your company to execute the award at the belated stage without cogent reasons is not acceptable and is contrary to the terms and conditions of the tender. Consequent upon failure on part of your company to adhere to the terms and conditions of the tender and derailing an important activity envisaged by the Department of Health and Family Welfare, Govt. of Punjab, this office is constrained to take following decisions against your company:

1. The EMD amounting to Rs. 400000/- submitted by your company against the above tender is forfeited.
2. Your company M/s Touchwood Entertainments Ltd is hereby debarred from participating in tenders to be initiated by the PHSC for a period of five years from the issue of this letter.
3. Further necessary action is being initiated against your company M/s Touchwood Entertainments Ltd as per the terms and conditions of the tender document.
