SEALED QUOTATIONS are invited for the purchase of 3957 Gross of PLASTIC PHIALS (1 DRAM) for use in Government Homeopathic Dispensaries in the State of Punjab. **The sealed Quotation must be reached in this office (at the above mentioned address only) within 03 days positively from the date of issue of notice but not latest by 11.05.2020 upto 12.00 noon through posts or by hand.** The specifications of the item required is as follows:-

2. Further details regarding the other Terms and Conditions for the above Quotation are as follows:-

- a) The bidder should quote only for the item for which the bidder fulfills all the terms & conditions
- b) The bidder should quote the rates of the items in the following prescribed format only:-

- c) Quantity mentioned above is tentative requirements and may be increased/ decreased as per actual requirements at the time of placement of order.
- d) A certificate/undertaking in support of manufacturing and marketing of the product is to be submitted.
- e) The bidder should quote only one rate for the item without any variation for different areas or any escalation clause. Rates quoted should be given both in words and in figures.
- f) The name of the manufacturer, and the brand name should also be stated.
- g) Quote the Rates only, if the item can be supplied immediately on demand or latest within FIVE (5) days from the date of confirmation of supply order.

- h) No figures or words should be overwritten. Incorrect figures and words should be scored out and rewritten under proper attestation.
- i) Each & every paper/page of the Quotations documents should be serially numbered and duly signed by the bidder.
- j) Enclose a valid sale/re-packing license where applicable.
- k) **The goods are to be supplied 05 F.O.R. destination at District level Government Homeopathic Dispensaries at Kapurthala, Faridkot, Sangrur, Ludhiana and Sahibzada Ajit Singh Nagar (Punjab) and all the transit loss whatsoever will be borne by the firm (any monetary limit is not acceptable).**
- l) It should be clearly mentioned that bidder is itself Manufacturer or Whole seller/Re-seller
- m) If the successful bidder fails to execute the supply order/N.O.A within the stipulated period, penalty @ 0.25 % per day of the value of the order not supplied will be levied. The cut of date of delivery period shall be counted from the date of actual dispatch of supply orders to date of receipt of supplies at FOR destinations.
- n) A certificate/undertaking certifying that the bidder is not debarred/blacklisted by any Government or Government undertaking in India.
- o) If the above instructions are not adhered to by the bidder, the Quotation may summarily be rejected and the Homoeopathic Department, Punjab will not be liable to answer for the same.
- p) The Head of Homoeopathic Department Punjab reserves the right to reject any or all Quotations without assigning any reasons.
