

Subject: - COVID-19: Collection of Bio medical Waste by CBWTF.

Reference and in subsequent to letter no. PHSC/2020/1923-1969, dated 01.05.2020 with the same subject as above it is further issued to **Point No. - 8 'Cost and Payment' that:-**

1. **For CCC/ level 1 facilities:** The agreement and instructions given in the mentioned letter above will be followed as such.
2. **For level 2 Governemnt facilities:** They will make separate payment for collection of Covid waste at the rate of Rs.750/ visit. The same payment may be done from the funds of covid waste under the District Administration or as provided to the hospitals. Rest of the terms in the agreement Letter no. 337-354, 355-373, 374-382, 383-398, dated 01.06.2016 shall be applicable for these facilities.
3. On generation of covid waste in the **Level-2 facilities (Government hospitals)**, a call will be made for a vehicle for covid waste collection and disposal by the concerned hospital to the authorized firm.
4. For serial no. 2 & 3 above and issued in consonance with the CPCB guidelines "CPCB B-31011/BMW(94)/2020/WM-1 April 19, 2020, Revision 2- Guidelines for Handling, Treatment and Disposal of Waste Generated during Treatment/ Diagnosis/ Quarantine of COVID-19 Patients 18th April, 2020 [In suppression of earlier guidelines uploaded at CPCB website on 25/03/2020]' the covid waste shall be disposed off in a separate vehicle with separate workers with complete protection for workers and also taking absolute precautionary measures by all the 5 CBWTF of Punjab.


To ensure doing agreements of all Isolation Hositals/ Wards for covid-19 waste with the authorized firm attached with each district with the changes as mentioned above.
