
Subject: - Reporting of COVID-19 Waste through Software developed by CPCB.

Central Pollution Control Board has developed software (Mobile version as well as desktop version) to track and log COVID-19 waste from all sources, preventing its accidental spillage, analyzing the data for strategic planning and feed back by creating necessary software. The software can be downloaded from the given website <https://bwm.cpcbccr.com>

After downloading the application, the following steps to be followed by various stakeholders:

- 1) Registration by Waste Generators (i.e. Isolation wards/Quarantine Centres/Sample Collection Centres/Laboratories/ULBs in case of Quarantine Homes/Covid Care Centres) and CBWTF
- 2) Waste Tracking by Waste Generator, Waste handler and CBWTF
- 3) Verification and approval by State pollution Control Board.

Therefore all CCC and all other centres dealing with COVID-19 Bio Medical Waste generation and its disposal should make a registration on the said software immediately and to send the daily data in the said software w.e.f. 08.05.2020 and onwards as no manual data of COVID-19 waste will be accepted thereon by CPCB and PPCB.


