**Subject: Partial amendment in order no. PHSC/Proc./HC/2020-21/5765 Dated 11.08.2020 regarding debarring for period of two years, due to non execution of order no. PHSC/Proc./Award-HC-EDL/2020/16566 dated 31<sup>st</sup> March' 2020 (10282000189).**

This is in reference to your request vide e-mail dated: 15/09/2020 regarding revocation of order no. PHSC/Proc./HC/2020-21/5765 Dated 11.08.2020 dated vide which following actions were initiated against your firm due to non execution of order no. PHSC/Proc./Award-HC-EDL/2020/16566 dated 31<sup>st</sup> March 2020 (10282000189) pursuant to clause no. 22-B, 22-C, 23, 24, 30 and 34-A:

1. The Rate Contract no. PHSC/Proc./RC/HC-ELD/2019/10149-10160 dated 30.01.2019 (Valid Till 29.01.2021) for supply of Sterilized Surgical Gloves stands cancelled and Security deposit of your firm/company amounting to Rs. 675000/- against the above Rate Contract stands forfeited.
2. Your company M/s St. Marys Rubbers Pvt. Ltd is hereby debarred /blacklisted from participating in tendering process of this office for all the items for a period of two years from the date of issue of this letter.
3. To recover from your company, the excess amount spent by the office on procurement of Surgical Gloves from outside the Rate Contract as Risk Purchase.

Keeping in view the position explained by your representatives, circumstances/position resulting from lockdown due to COVID and prevailing pandemic situation as well as supplies made by your firm subsequently though still delayed, the order no PHSC/Proc./HC/2020-21/5765 dated 11.08.2020 are hereby amended to the following extent without setting any further precedent and as a onetime relief.

1. The Debarring of your company from participating in tendering process of this office as per order no. PHSC/Proc./HC/2020-21/5765 dated 11.08.2020 is hereby revoked.
2. Other penalties for delayed supplies as mentioned in the above orders shall remain same.

Your company is advised to strictly adhere to the terms and conditions of the rate contract in future .The performance of your company will be monitored with regard to adherence to the terms and conditions of the Rate Contract for the remaining period of the validity of the Rate Contract.
