1.	Agreement/ Validity (Tender Condition No. 07)	:	The agreement with empanelled laboratories will remain valid for two years from the date of issue of this Contract Agreement.  This can further be extended for a further period as specified in tender document with mutual consent.					
2.	Performance Security (Tender Condition No. 10)	:	The empanelled laboratory has to submit Performance Security of Rs. 25,000/- in the form of demand draft in favour of Managing Director, Punjab Health Systems Corporation, Payable at Chandigarh or Sahibzada Ajit Singh Nagar (Mohali) within 15 days from the date of receipt of this letter.					
3.	Complete Analysis & Reporting Conditions (Tender Condition No. 11)	:	On empanelment and entrustment of the job, the Analytical Laboratory should furnish the test reports as per following schedule:     I. 15 days from the receipt of the sample in case of (non-sterile products) etc.      II. 21 days from the receipt of the sample in case of (Sterile products) etc.

	h) Test reports shall include related substances wherever applicable.
	<ul> <li>i) Reports should be attached along with Spectral Chromatography data sheets, if applicable and it will be considered incomplete if spectra or chromatograms are not allowed.</li> </ul>
	2. All the reports of each batch of sample should be submitted to the PHSC in triplicate. In case of failure of a sample, the result should be communicated immediately to the Central Quality Control Cell of the PHSC through Phone/email and the report should be sent along-with protocol.
	3. If in any circumstances (like break down of instrument, non availability of reference standard etc.) the Analytical Laboratory is unable to undertake analysis for a sample, the same should be reported within 24 hours of receipt of such a sample by Phone or email and the sample should be returned to the In-charge Central Quality Control Cell, Punjab Health Systems Corporation, SAS Nagar (Mohali) after taking necessary telephonic or mail consent. In case of inability of laboratory to undertake the testing a penalty @ 25% of testing charges applicable for the product/products will be recovered.
	4. If placebo or standard test procedure of any product is required the same should be demanded within 48 hours with return request. Period lased/taken in providing placebo or standard testing procedure will be condoned from prescribed time for that sample.
	5. If any sample is received in a damaged conditions by the Laboratory, the sample should not be analyzed and the information should be sent immediately to the In-charge, Centra Quality Control Cell, PHSC, SAS Nagar (Mohali) by fax or email.
	6. The Managing Director, PHSC or his authorized representative(s) has/have the right to inspect the laboratories of the Bidders who have submitted BIDs, before taking any decision regarding empanelment. Similarly, the Managing Director, PHSC or his authorized representatives may also inspect any empanelled laboratory, at any point of time during the continuance of the Contract and terminate/cancel its empanelment or any orders issued to the laboratory, not to entrust any further testing job to the laboratory based on facts brought out during such inspections.
	7. The successful lab shall have to make own arrangement for collection of sample, from PHSC, Headquarter.
	8. It will be sole discretion of PHSC to allot the samples to any empanelled lab in case when there are more than one lab approved for an item.

		NOTE: - Fraction of a day in reckoning period of delay in furnishes the test report shall be eliminated if it is less than half a day. The maximum amount of liquidated damages shall be 10%.
