Part - I : TECHNICAL BID

- **Step-3:** The bidder will have to deposit payment online for the purchase of bidding document and EMD amount prescribed in the bid document.

Part-II-: PRICE BID

4)	List of equipment and machinery available (either owned or leased) with documentary proof of ownership/lease document and machinery proposed for deployment for execution of work.	
5)	List of key personnel with qualification and adequate experience proposed for this work (as per Annexure-II Staff).	
6)	Evidence of access to line(s) of credit/ Bank solvency certificate/ availability of other financial resources facilities (10% of DNIT amount), certified by the Bankers (Neither more than 3 months old from the date of publication of tender nor after the closing date of tender).	
7)	Undertaking that the bidder will be able to invest a minimum cash upto 25% of contract value of work, during implementation of work.	
8)	Copy of valid EPF registration certificate from Provident Fund Commissioner. If not applicable, then an Affidavit/undertaking must be given for the same.	
9)	Copy of valid Permanent Account Number (PAN) issued by Income Tax Department	
10)	Copy of valid GST Registration Number issued by concerned department	
11)	Affidavit/undertaking of not having been black-listed by any Govt. /Semi Govt. Organization/Corporation at any stage and/or debarred by PHSC or any other Regional Development Authority	
12)	Litigation History , if any, regarding any work or service provided by the agency to any Government department or Public body or private entity.	
13)	Financial turnover/ Reports on financial standing of the Bidders, such as profit and loss statements and auditor's reports for the past five years along with CA Certificate.

15)	Undertaking/Authority to seek references from the Bidder's bankers (Given to the Employer or his representatives)	
16)	Affidavit/undertaking that information being submitted is correct and true, and that any false information shall lead to disqualification at any stage.
